Textual Information(1)	<p>Please note that Ram Ratna Research and Holdings Private Limited (RRRHPL) and Jag-Bid Finvest Private Limited (JBFPL) have been merged with Hemlata Home Solutions Private Limited ("HHSPL") pursuant to a Scheme of Amalgamation which became effective from October 1, 2025. All the abovementioned entities, viz., RRRHPL, JBFPL and HHSPL, belong to the Promoter Group and are reflected in the shareholding pattern under para A(1)(d). Pursuant to the said Scheme of Amalgamation, and also as intimated by the concerned parties vide the intimations filed in the month of October 2025 under the SEBI (Substantial Acquisition of Shares & Takeovers) Regulations, 2011, the respective shareholding of RRRHPL and JBFPL in R R Kabel Limited is now held by HHSPL, the transferee company. However, the process relating to updation of name in the demat accounts of RRRHPL and JBFPL is currently in progress, due to which the names of RRRHPL and JBFPL continue to appear in the beneficial position (BENPOS) obtained from the Depositories as on December 31, 2025. Accordingly, the Shareholding Pattern has been prepared and reported based on the BENPOS data available as of December 31, 2025, reflecting the separate names as appearing therein.</p>
